President's Message

It is the responsibility of everyone involved to ensure that communication is facilitated if the purposes of the organization are going to be met. And this communication must be twoway.

CSA's mandate is to organize meaningful professional development, identify issues of concern and advocate for its members. You

are the primary target of our PD. When it comes to advocacy, our primary targets are (1)the Alberta Teachers' Association, in the anticipation that the ATA will bring forward priorities and resolutions that recognize the demands on school-based administrators, and (2) Alberta Education, with the hope that policies, regulations, initiatives and priorities are developed in consultation with schoolbased administrators. We also seek opportunities to liaise with the College of Alberta School Superintendents, Alberta School Boards Association, Alberta School Councils' Association and the postsecondary institutions in Alberta. I am fortunate to sit on Alberta Education's School Leadership Framework committee where representatives from all the above groups have come together to develop recommendations to guide school leader preparation, professional growth, supervision and evaluation, and to support the development of quality school leadership in Alberta. The overall goal of this collaborative initiative is to ensure that all Alberta schools are served by highly qualified educational leaders whose work focuses on the provision of optimum learning opportunities for and the development of all students in the school.

I am heartened that stakeholder representatives around the committee table have a deep understanding of the magnitude of the expectations on school leaders. While there are many supporters of school administrators, when it comes to the competition for scarce resources, this support may diminish in favour of other priorities. The dynamics of decreasing resources is that what is good for school leadership can easily be overlooked when there are so many "important" special interests.

For that reason we must have consensus on what the role of school leadership is in this province, who has the responsibility for the development of school leaders and, more important, how the administrator's role is defined to our different publics, which include teachers, parents and trustees.

If school administrators do not advocate for their roles today, a lack of capable people and a lack of resources to support current school leadership will continue into tomorrow. If we school administrators do not speak up for the issues that we face, we burn ourselves out, do only an adequate job of the myriad of responsibilities, and compromise our time and energy dealing with emergencies in education rather than with the realities of educational leadership. If instructional leadership is our most important role, our membership needs support, either as a significant increase in administrative time allocations to schools or a reduction of expectations put on school leaders. Our lives need not be a compromise. Although we are generally very pleased with our jobs, it is not a surprise that younger educators are not lining up to fill the openings in administrative positions.

To support you in your role, the CSA executive needs to hear from you. Come to functions hosted by your CSA regional. Share in the dialogues. The CSA executive works to provide those opportunities to connect with you.

CSA plans to host regional meetings in your area on *Leadership for Learning: The Experience of Administrators in Alberta*, an ATA research update that was published in June 2009 and sent to all schools and superintendents last spring. We also hope that at these meetings we can update you on Alberta Education's efforts to support school administrators and deal with the anticipated shortage of qualified school administrators.

CSA has the support of stakeholder groups that understand some of the needs. The CSA needs the participation of schoolbased administrators to consolidate the message and strengthen our voice.

Here is an update of the SWCSA activities planned for the 2009/10 school year.

On the evening of November 30, SWCSA will host a dinner meeting with Dr Jim Parsons at the Sandman Hotel in Lethbridge. Up to 50 school administrators will be present to hear Dr Parsons share the initial findings of a research project on the role of instructional leadership in building capacity of school administrators. Sponsored by the Alberta Teachers' Association, this important study will illustrate how the Principal Quality Practice Guidelines present an opportunity for school administrators to support quality instruction and assessment practices that promote real learning in Alberta classrooms.

We are coordinating another dinner evening with Dr Dennis Shirley on February 23. Dr Shirley coauthored *The Fourth Way: The Inspiring Future for Educational Change* with Dr Andy Hargreaves. School administrators, superintendents and school board members should attend.

Throughout the year SWCSA will work closely with the Southwest provincial executive council to promote Real Learning First. One idea that came from our September 14 meeting is the sharing of Real Learning First podcasts with district administrators and teachers. By working closely with the district representative, we hope to enhance stakeholders' awareness of Real Learning First.

Julius Buski Leadership Grant

The Julius Buski Leadership Grant recognizes projects and practices that have contributed to the enhancement of teaching and learning. An individual teacher or a group of teachers may be nominated for this grant. Nominated initiatives must have been in place for a minimum of one calendar year and must show evidence that teaching and learning have benefited.

The Julius Buski Leadership Grant will be awarded annually, unless there is no suitable applicant. The school that receives this grant will receive a \$500 grant to support its initiative and will be formally recognized during the Western Canada Educational Administrators' Conference (WCEAC).

Applications must include the names and signatures of the school's principal or assistant principal(s) and one teacher on staff who has worked directly with or has knowledge of the project. Application forms are available from any member of the provincial executive; a copy of the form is included with this newsletter. The deadline for applications is March 1, 2010.

Criteria

Applicants are required to

- be current members of the ATA. The principal or assistant principal(s) must be current member(s) of the CSA;
- provide a one-page write-up describing the school and the project and/or practice, including specific examples of how teaching and learning have been enhanced because of the project. Dates when the project and/or practice was implemented and reasons for implementation should also be included;
- be available for a brief interview (in person or by telephone), during which a member of the selection committee will ask questions about the innovation. An interview schedule will be developed; and
- be willing to make a one-hour presentation on the initiative to colleagues at the WCEAC following the awarding of the grant. Any reasonable costs associated with this presentation (including transportation to and from the conference and one night's hotel accommodation if necessary) will be covered by the WCEAC program planning committee.

Conferences

There are plenty of opportunities to attend conferences in the new year.

You will not want to miss the Banff Leadership Seminar, which takes place in beautiful Banff, Alberta, on March 17–19, 2010. Watch the CSA website for further details.

Another conference that has a national flavour is the Canadian Association of Principals (CAP) 2010. This conference will take place in Regina, Saskatchewan, on April 22–24, 2010. Check the CSA website for further details.

Thinking a little further ahead, we will have the opportunity to attend the International Conference of Principals convention, which will be held in Canada for the first time ever. It will take place in Toronto in August 2011. Check the CSA website for further details.
